#### <u>Apology</u>

On 11th June 2018 a letter of apology from Yvonne Smart, Chairman of Trimley St Martin Parish Council, was sent to Mr Ian Cowan (Trimley St Martin Parish Councillor 2006 to 2015). The body of the letter is as follows:

I am writing to you in my capacity as Chairman of Trimley St Martin Parish Council. Having joined the Council in 2017, I have no direct personal knowledge of the matters explored by the Deputy Monitoring Officer of Suffolk Coastal District Council in his report into your code of conduct complaints. Although the Deputy Monitoring Officer did not uphold the complaints you made against six current councillors and three former councillors, he did draw attention to the inclusion of false and misleading statements in the agenda for the meeting held on 1 March 2016. These statements, which were repeated in the minutes of that meeting, presented allegations about you as though they were established facts. The statements said that you had been responsible for bullying and harassing other Councillors, the Clerk and the Internal Auditor.

The allegations had previously been included in a Code of Conduct complaint against you, but in 2015 the then Deputy Monitoring Officer had found that they were not justified. The allegations should not have been included in either the agenda or the minutes and I am writing now to apologise on behalf of the Parish Council for the fact that they were included. In order to make the position clear the following steps will be taken:

- a correction will be appended to the March 2016 agenda and to the minutes of that meeting;
- a link to a copy of this letter will be placed on the homepage of the Parish Council website to remain there for a period of six months, and
- a copy of this letter will be published in the Parish Pump.

I hope that it will now prove possible for the difficulties of the past to be put to rest and that everyone concerned can now move forward.

## Road, Rail and Foopath

#### **Network Rail Upgrade Works**

The machines which prepared the ground for the new track and ballast will soon complete their work and be replaced by rail mounted vehicles laying the track and sleepers. The next major element of work will be the installation of new signalling equipment which is currently scheduled to take place over the 2018 - 2019 Christmas to New Year period.

Ben Porter, Senior Project Manager for VolkerFitzpatrick, is keen to maintain the positive relationship with local people. With summer holidays approaching he would like to remind everyone, especially young people, that construction sites and the railway are extremely dangerous places. Ben and his team take care to keep the site secured, but if you have any concerns please speak to a manager or call at the site office.

#### Roundabouts and Beds – An update

Last month we reported on the overhaul of the planting to the roundabout and surrounding beds which was carried out with the generous assistance of Taylor Wimpey. Sadly, thieves have stolen many newly planted shrubs, including Choisya Sundance, Red Robin, Spirea and Weigela, from the bed next to the bus stop in Howlett Way. The first shrubs were stolen in May and more were lost in June. If you have any information about this, or if you have recently been offered plants like these for sale from an unexpected source, Suffolk Police would be pleased to hear from you.

#### **Diversion of Traffic Through Trimley St Martin**

Unfortunately, a further diversion of A14 traffic may take place in the late summer or early autumn. We do not yet have full details but Parish Council representatives have met with Highways England and Suffolk County Council Highways to explain what a major problem these diversions cause for local residents. Regulations prevent the use of contraflow - the A14 is too narrow for this to be done safely- so Highways England and Suffolk Highways are going to work together to explore how best to keep problems to a minimum. They will be considering several ideas including an advisory 20 mph speed limit, and weekend working to coincide with low HGV traffic.

#### Land off Howlett Way

The Trimley Estate is promoting an outline planning application on land to the south of Howlett Way, which was identified for development in the Felixstowe Area Action Plan. The proposals are for up to 360 new homes, an Early Years (nursery education) Centre, and open space. The houses will be a mix of types and styles, including up to one third affordable housing. The plans will include houses suitable for elderly people looking to downsize and young families looking to have their first property. Alongside the new homes, the Trimley Estate will be working with the District Council to agree appropriate contributions towards local infrastructure including primary and secondary education.
